5:00 PM: Seawall Park in Langley. Formal landing of the canoe with protocols.

**6:00 PM**, **dinner provided by NCI**: For the 3rd year, NCI has been invited to provide dinner for the canoe family and other Snohomish Tribal members on their arrival day. **Volunteer** to help: **sign up** <u>here</u> or call Michelle Munro, volunteer coordinator, at 206-696-2629.

Sunday, July 7: 12:00 Noon: Community Potluck Meal and Salmon Bake followed by cultural sharing at the Fairgrounds. All are welcome to bring a potluck contribution and share in the meal. It will be followed by presentations, songs, dances, and other cultural gifts from both the Blue Heron Canoe Family and the Snohomish Tribe.

**Mon-Thu, July 8-11:** The Blue Heron Canoe Family invites everyone to **visit** their encampment throughout the week and participate in teachings, songs, craft-making, ceremony, and informal discussions. Feel free to take them a pot of soup, a loaf of bread, some cookies, or some garden produce, and stay to get to know them.

The canoe family is offering to schedule some **workshops**. Possible activities include paddling the canoe (tide and wind dependent), wood burning, cedar weaving, beading, nature observance, plant ID, native games, song/dance, and storytelling. **If interested**, **email** <u>nciwhidbey@gmail.com</u> for the workshop schedule once it's available.

The Power of Youth: Our Children's Trust Wins Again! The youth plaintiffs in <u>Navahine v. Hawai'i Department of Transportation</u> have secured a historic victory! A groundbreaking settlement agreement recognizing children's constitutional rights to a life-sustaining climate has forced the Hawai'i Department of Transportation (HDOT) to plan and implement transformative changes to fully decarbonize Hawai'i's economy and transportation system by 2045! \*Thirteen years in the making, Navahine v. Hawai'i Department of Transportation is the first settlement in a constitutional climate case bringing systemic decarbonization of a state transportation system. #### Extreme Heat Across the U.S.

This summer is forecasted to be the <u>hottest on record</u>, and the heat waves are getting an early start throughout much of the U.S.. Even though it's only June, about <u>5 million</u> <u>people</u> live in areas of the U.S. expected to have dangerous heat this week. Most of the Southwest and Arizona are among the areas forecasted to reach temperatures in the 110 degrees, and the weather in the Northeast is record breaking. Globally speaking, May was the 12th consecutive hottest month on record and June is on track to be the next.

This further <u>reinforces UUSC's contention</u> genocide is happening in Palestine and pleads for immediate ceasefire. Summary of the war's major impacts:

- destroyed water, sanitation, hygiene, systems
- eliminated a large portion of Gaza's solar infrastructure
- · bombings have generated 39m tons of debris
- reversed Gaza's limited environmental gains

As we continue to witness devastating violence and destruction in Gaza, we are called by our commitment to love & justice and call on university administrations and public officials to remove police from campuses, end the militarized response to student activism and come to the table in good-faith negotiations with student demands. a "soft" genocide continues to unfold in this open air prison.*

**UUs stepping up to the Climate Challenge! On September 28-29, congregations will host UU Climate Justice Revivals** to collectively reimagine a spirit-filled and liberatory future. Through conversations, worship and advocacy congregations will work together to realize climate justice and collective liberation. Everything needed to host a revival will be available in August including: discussion guides and materials for all ages, training, worship resources and advocacy actions designed to transform our communities through climate justice. Please Support the "Earth Bill" a bonafide solution to our climate crisis. UUSJ has joined a growing group of organizations endorsing this essential bill. It is gaining support but we need to encourage our representatives and Senators to co-sponsor it. The Earth Bill supports a comprehensive transition to renewable energy, requiring 100% renewable electricity, zero-emission vehicles, and regenerative agriculture by 2030.
